

WRIGLEY SPRING INSTORE PROMOTION

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, PLAY OR CLAIM A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. A VALID EMAIL ADDRESS IS REQUIRED.

- 1. ELIGIBILITY:** The Wrigley Spring Instore Promotion (the "Promotion") is offered only to legal residents of the 50 United States and the District of Columbia, who are 18 years of age or older at the time of entry. Void where prohibited or restricted by law. Employees, officers and directors, and their immediate family members (spouses, siblings, parents and children, including foster and step-relations, and their respective spouses) and household members (whether or not related) of Wm. Wrigley Jr. Company ("Sponsor"), TPG Rewards, Inc. ("Administrator"), The Integer Group, Marvel Entertainment Inc. PROMOTION PERIOD:** Promotion starts on or about 12:00 a.m. Central Time (CT) on March 1, 2017 and is scheduled to end at 11:59:59 p.m. CT on April 30, 2017 or when 1,000,000 Promotion Codes (defined below) have been distributed, whichever occurs first ("Promotion Period"). The clock on Administrator's server is shall be the official time keeping device for this Promotion.
- 3. HOW TO ENTER:** There are two ways to participate in the Promotion:

 - a. Enter with a Promotion Code.** During the Promotion Period, an eligible entrant ("Entrant") must visit a participating U.S. Circle K store and purchase Singles size packages of SKITTLES® (Original, Wild Berry, Sour 2.17 oz packages) or M&M's® (Peanut , Chocolate, or Peanut Butter 1.74 oz packages) candy to receive a unique code ("Promotion Code") printed on the Circle K Value Advantage Printed Receipt ("Receipt") generated at the cash register at check out. Then, the Entrant must access www.winthegalaxy.com (the "Website") and register for the Promotion by following the online directions to submit his/her first and last name, street address, state, city, ZIP code, email address, daytime telephone number, birthdate, and agree to be bound by these Official Rules and the decisions of the Sponsor and Administrator. After successfully completing registration, enter the Promotion Code from the Receipt where indicated and press the SEE IF YOU WON button. Promotion Codes must be submitted during the Promotion Period. Promotion Codes are void and will be rejected if not obtained through authorized, legitimate channels or if any part is counterfeited, forged or otherwise tampered with. **Important:** If the Entrant is participating in the Promotion

via a mobile device, message and data rates may apply. The Entrant should consult his/her wireless service provider regarding its pricing plans. Participation may not be available on all mobile devices, as not all mobile devices or cellular telephone providers have the capabilities or carry the service necessary to participate in this method of entry.

- b. One Promotion Code will be assigned and played on your behalf. Only winners will be notified.

Limit one (1) entry per person or e-mail address per day, regardless of the method of entry. A “day” is defined as 12:00:01 a.m. ET through 11:59:59 p.m. ET. You may enter the Promotion under one name/e-mail address only. Potential winners who participate by mail will be notified by postal mail, telephone, email or other method determined by Sponsor. All prize claims are subject to verification by Administrator.
